Wis. Stat. § 97.67 (5) and 97.605 (1)(c) "No license may be issued until all applicable fees have been paid."

Wis. Stat. § 97.67 (1) "No person...who has not been issued a license under this section may conduct, maintain, manage or operate a campground and camping resort, recreational camp and educational camp or public swimming pool, as defined by department rule."

Wis. Stat. § 97.605 (1)(a) "No person may conduct, maintain, manage or operate a hotel, restaurant, temporary restaurant, tourist rooming house, vending machine commissary or vending machine if the person has not been issued an annual license by the department or by a local health department that is granted agent status under § 97.615 (2)."

Within 30 days after receiving a complete application for a license, the department shall either approve the application and issue a license, or deny the application. If the application for a license is denied, the department shall give the applicant reasons, in writing, for the denial.

Re-inspection fees will be assessed based on license category, for any required re-inspections, per State Code.

All permits expire June 30th of each year. An \$85 Late Fee will apply to all establishments if yearly renewals are not received by date due.

A \$749 Operating without License fee will be issued for all facilities that are operating without a current permit.

A license shall not be issued to an operator without prior inspection.
